## **RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**

In consideration for being permitted to utilize the facilities, equipment, services and programs of the YMCA of MEWSA/Jewish Community Center of Middlesex County (JCC) (hereinafter referred to as the "Edison Community Campus") for any purpose, including but not limited to, observation, visiting, touring or use of the Edison Community Campus, or participation in any program affiliated with the Edison Community Campus or the YMCA/JCC, without respect to location, the undersigned, for himself or herself or any personal representatives, heirs, and next of kin, hereby acknowledges, agrees and represents that he or she has, or immediately upon entering or participating will inspect and carefully use such premises and facilities or the affiliated program.

It is further agreed that such entry onto the Edison Community Campus for observation, visiting, touring, or use of any facilities or equipment or participation in any affiliated program constitutes an acknowledgement that use of the Edison Community Campus, its equipment, services and programs thereon and participation in the YMCA of MEWSA/Jewish Community Center programs may be hazardous to me. By participating in the YMCA Nationwide Membership Program, I agree to release the Jewish Community Center of Middlesex County and the National Council of Young Men's Christian Associations of the United States of America, and its independent and autonomous member associations in the United States and Puerto Rico, from any claims for bodily injury or death, **including sickness or disease sustained from the use of or in connection with the use of YMCA/JCC facilities**, and from any liability for other claims, including loss of property, to the fullest extent of the law.

**I am aware of the risks of using the Edison Community Campus, its equipment, and services, and programs. I assume all risks both known and unknown to me resulting from use of the Campus and its services and participation in its programs. and I am aware that participation in YMCA of Metuchen Edison Woodbridge & South Amboy and/or JCC programs and activities ("Programs") comes with inherent risks including, but in no way limited to: (1) moderate and severe personal injury, (2) property damage, (3) disability, (4) death, and (5) sickness or disease. I voluntarily accept and assume full responsibility for these risks as well as any and all other risks of the use of Facilities and participation in Programs. I agree that I have full knowledge of the nature and extent of all such risks and am not relying on all such risks being described in this document.**

The Edison Community Campus and the YMCA/JCC conducts regular sex offender screenings on all members, participants, and guests. If a sex offender match occurs, the Edison Community Campus and the YMCA/JCC reserves the right to cancel membership, end program participation, and remove visitation access. IN FURTHER CONSIDERATION OF BEING PERMITTED TO ENTER THE EDISON COMMUNITY CAMPUS AND/OR THE YMCA/JCC FOR ANY PURPOSE, INCLUDING BUT NOT LIMITED TO OBSERVATION, VISITING, TOURING OR USE OF FACILITIES OR EQUIPMENT, OR PARTICIPATION IN ANY PROGRAM AFFILIATED WITH THE EDISON COMMUNITY CAMPUS AND/OR THE YMCA/JCC, WITHOUT RESPECT TO LOCATION, THE UNDERSIGNED HEREBY AGREES TO THE FOLLOWING: THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the EDISON COMMUNITY CAMPUS, THE YMCA/JCC, its directors, officers, employees, and agents (hereinafter referred to as "releasees") from all liability to the undersigned, his, her or their personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in, upon, or about the premises or any facilities or equipment therein, or participating in any program affiliated with the Edison Community Campus, and/or the YMCA/JCC, without respect to location. \_\_\_\_\_(initial) THE UNDERSIGNED
