## Bright Beginnings Preschool at the JCC of Middlesex County 2026-2027 School Year Tuition and Fees



**Welcome to the Bright Beginnings Preschool at the Jewish Community Center of Middlesex County. We thank you for entrusting your child to us and we look forward to working together with you resulting in an exciting and rewarding school year!**

The following information outlines the tuition and fees associated with your child's enrollment in the ten-month **Bright Beginnings Preschool** program. Please read the terms carefully and acknowledge your review and agreement with your **initials**:

- Preschool enrollment and tuition is a full school-year commitment (10 months)
- Tuition is based on a nine-month obligation and is **not** a monthly enrollment or payment
- Remote learning is considered a full learning experience of the **Bright Beginnings Preschool**. In the event that the school and JCC are closed or otherwise required to conduct and operate remotely or virtually, there will be **no** refunds or transfers of tuition and fees.
- Your child's placement in the program will be held **only** with payment of the full-year tuition whether you withdraw from the program or are absent for extended periods.
- No refunds of tuition or fees will be granted after June 30, 2026 for those who register early with the discount.
- All fees, including the one-time Administrative Fee of \$50.00 and Tuition payments are **non-refundable and non-transferable**, and are applicable only to the 2026-2027 school year.

**-Community Campus Membership** is required on a yearly basis for each child or family.

**-Payment in full** affords you a discount of 5% from your tuition fee.

**-Tuition Payment Plans** are available if you choose not to pay in full at the time of registration. Tuition notices are delivered by email. Please update the preschool office of any changes in email addresses.

**-The Tuition Payment Plan** requires 20% of the tuition fee paid to the **JCC Bright Beginnings Preschool** as a **Deposit** at the time of registration for your child. The Balance of the 2026-2027 school year tuition shall be paid to the **JCC Bright Beginnings Preschool** in **nine (9) equal monthly payments** due on the **first (1st) day of each month** beginning with the first installment payment due on or before September 1, 2026 and the final installment payment due on or before May 1, 2027.

\*\* **Installment payments** received after the 1st day of the month shall be subject to a **Late Fee** of twenty-five (\$25.00) dollars.

\*\* To avoid late fees and to enable you to process and pay the tuition more conveniently, the **JCC Bright Beginnings Preschool** offers auto-debit payments through an online tuition system which can be arranged through our Preschool Billing Office.

\*\* Payments by check shall be made payable to: **JCC of Middlesex County** and are either hand-delivered or mailed to JCC of Middlesex County, 1775 Oak Tree Road, Edison, New Jersey 08820, ATTN: **BRIGHT BEGINNINGS PRESCHOOL**.

\*\* There will be a 9% discount for **siblings** in the **Bright Beginning Preschool** program with the discount applied to the second child’s tuition only.

\*\* There is a discount of **3% off the tuition** for all payments made by cash, check, or EFT.

\*\* Early Drop-Off between 7:45 a.m. and 9:00 a.m. will be charged @\$75.00 per month.
